b. SCFT (Nelson, Inez, Keith) – Keith also announced that the Local will do phonebanking with our members to talk about our candidates and Prop 15.

a. Bargaining/Negotiations Update (John and Keith)

1. 20/21 Evaluations MOU (see attached)

– SCFT signed the PT Eval MOU on September 3rd. Still working on the FT MOU. We need to work on a standardized version of these eval forms.

2. Compensation for Online Migrations (from Spring)

3. Eval Forms – Keith announced that he will send out a doodle poll about this to collect data.

4. Chairs Handbook – Mark raised concerns over the voluntary peer evaluation suggested in the latest FCC chairs' handbook. He raised the argument that such an evaluation, even though it is voluntary, should not be in there. Such a practice will be used in negotiations to insist that it become formal – or to insist that some other item be conceded in order to get the district to drop this demand. Merely suggesting it may blowback on this.

Paul pointed out that the chairs have a meeting on October 16 and will report back.

In addition, concerns were raised that the District has done such a poor job of diversifying the faculty in the past, that it is difficult to put together diverse committees without unduly increasing the workload of people of color.
