- **4. Approval of Minutes:** February 24 and April 27 Exec Council -- **M: Nelson Esparza moved to approve.** 2nd: Enid Perez approved unanimously.
- **5. Membership Drive** Keith thanked those who joined in and made calls in the recent phone bank. 384 calls 67 conversations. Keith also announced the numbers in the Union Town Hall 154 attended. Great turnout.
- **6. Discussion Items** (30 minutes)
- 6.1 a. DE Training -- Moved to 7.2 COVID-19
- b. Bargaining/Negotiations Update Keith discussed the on-going negotiations aournd an MOU for the fall. Among the major issues are stipends or labs, class caps and PPE. There was some discussion of lay-off language too. Word is that Dual Enrollment is not to be prioritized.
- c. Budget Ideas some discussion was had around how the district could save money considering the emergency. That is, how can the District trim costs without losing jobs. Among the topics discussed were the emergency power that boards have to move restricted funds into

unrestricted to help offset costs; the possibility of a golden handshake; the possibility of reduced contracts or volunteer furloughs.

- 6.2 Bargaining Unit Data (Inez) Inez reported on continuing fluctuations of the membership. Lacy commented that the trend of folks moving in and out of the unit doesn't make sense.
- 6.3 Financial Update (Doug) Doug reported that we're holding steady but expressed concern over COVID related enrollment declines and potential PT lay-offs.
